The tuition fee for this programme for 2012 entry will be £8,000. If you are following the sandwich route, the cost of your placement year in 2014/15 is still to be determined. As a guide, the placement fee was £680 in 2012/13, and has historically increased by around 2.5% each year. This is subject to change, so please check out our website www.finance.mmu.ac.uk/students to determine the exact fee before you start your sandwich year.

International students

The tuition fees for students who do not qualify for UK or European Union (EU) status is £10,000 (2012 entry).

There are a number of organisations that award scholarships to international students. Many of these scholarships are awarded a year in advance so you are advised to start your research at least 18 months before you plan to start your course. In addition, the University has a limited number of partial scholarships which are made through the Vice-

If you are looking to develop expertise in the financial analysis of business activities or want to embark on a career in the accounting profession you should be considering our BA (Hons) Accounting and Finance degree.

The accountancy and finance sector offers a broad range of career choices. As well as the traditional accountancy roles of tax, audit, financial reporting and management accounting, professionals in this sector undertake broader business management and advice roles.

This degree, which assumes no previous knowledge of accounting or finance, combines accountancy, finance and economics with business disciplines. Alongside the development of your accountancy knowledge, there is a strong focus on developing your management skills to ensure that when you graduate

you have the full compliment of high-level skills that employers are looking for. For example, as well as learning how to write reports you will also have the opportunity to develop your presentation skills so that you are able to prepare well-researched business cases and financial reports and deliver your findings through persuasive, engaging presentations. If you choose the sandwich route, you can include a year's work experience as part of your course.

All of our staff are professionally qualified and many fulfil advisory or examining roles with the Association of Chartered Certified Accountants (ACCA), the Chartered

Institute of Management Accountants (CIMA) or the Institute of Chartered Accountants in England and Wales (ICAEW). We are also an approved platinum learning provider for the ACCA.

If you are looking to become a qualified chartered accountant, this course can give you a good head start. Both the full-time and sandwich routes provide the maximum number of exemptions for ACCA and ICAEW and nine exemptions for CIMA. This ensures that you will have fewer professional exams to sit once you have graduated and you will qualify in a much shorter time period.

Special Features

- Successful completion of this degree enables you to claim the maximum exemption of all nine Foundation papers of the ACCA, nine papers from CIMA or the maximum exemption of eight papers if you wish to become an ICAEW Chartered Accountant. Currently, we offer a range of professional and postgraduate programmes that enable you to complete your ACCA or CIMA examinations.
- The programme is accredited by the Association of Accounting Technicians (AAT). Graduates can apply for full membership of the AAT after completing the Level 4 Diploma Case Study Unit

and working full-time for one year. As a full member you will have access to CPD programmes, networking events, professional guidance and you may use the letters MAAT after your name. For more details visit www.aat.org.uk

- The degree enjoys a good reputation within professional circles and is well regarded by employers.

Sandwich Placements

A course with a sandwich route provides the opportunity to work for an organisation as part of your degree. This work experience is commonly referred to as a placement. It must be a minimum of 36 weeks but will usually last for 12 months and takes place after your second year of study. Your placement employer will pay you a salary which is typically between £12,000-£16,000.

If you choose the sandwich route, our Placement Office will help you find your placement. Our dedicated team has over 25 years' experience of matching students with employers and has been rated by students as one of the top four placement services in the UK (National Placement and Internship Awards 2010 and 2011).

The services they provide include:

- Organising an annual placement and career development fair where you can meet employers who have placement opportunities and graduate vacancies.
- Advertising over 1,000 vacancies from local, national and international employers each year.
- Delivering CV workshops that provide advice and tips about what to include in a CV and how to present yourself to your best advantage.
- Providing one-to-one advice about writing cover letters, CVs and application forms for the jobs you are interested in.
- Conducting mock interviews so that you can practice your interview technique and receive feedback on your performance.

It is your responsibility to be pro-active and apply for placement opportunities. The placement jobs market is competitive and we recommend that you start researching companies and opportunities during your first year and apply for positions from the start of your second year.

When you are on placement, one of our tutors will keep in contact with you and will liaise with your employer. The placement is not formally assessed but it must be satisfactorily completed.

Research indicates that students who undertake a sandwich year as part of their studies are more employable. In 2010, 93% of Business School graduates who had completed a placement and were in employment were in graduate occupations.

Assessment

Assessment throughout your degree will be both informal and formal.

The informal assessment will be based on work prepared for tutorials and your contribution to these tutorials together with homework questions which you may be required to submit. It will not form part of your formal marks but is useful for both you and your lecturer to determine whether or not you have understood material and whether you are working to a satisfactory standard.

The formal assessment includes examinations, group or individual presentations, written essays and reports, poster presentations and portfolios of work. Not every subject is assessed in the same way, but you will probably meet all these forms of assessment during your degree studies.

From the second year onwards, these formal assessment marks go towards determining the final classification of your degree from Manchester Metropolitan University. The work placement year is not formally assessed but must be satisfactorily completed.

UK/EU students

Tuition fees have increased for 2012 entry because government funding for higher education has been cut. However, the existing system of loans and grants has also been extended and improved to assist students in going to university. Your fees can be paid for by applying for a tuition fee loan and you will not have to pay any fees upfront. You do not have to start making repayments on student loans until the April after you graduate and only then if you are earning over £21,000.
