



## MMU's Executive MBA

### Corporate Sponsorship Tuition Fees Scholarship Scheme

#### The Offer – Corporate EMBA Scholarship

Where a Single Business Organisation supports the enrolment of two or more of their employees on an MMUBS EMBA, those student employees (whether sponsored by the employer or not) will be eligible for a 15% tuition fee scholarship (the “MMU EMBA Corporate Scholarship”).

#### Terms and Conditions

1. The MMU EMBA Corporate Scholarship is applicable to the Executive Masters of Business Administration only. The scholarship will take the form of a 15% reduction of the EMBA tuition fee per academic year. If a candidate qualifies for the scholarship, their fee will be adjusted accordingly with the scholarship being applied at the end of the relevant academic year. Only students who remain employed by the same qualifying Single Business Organisation\* (their “Nominated Organisation”) during the duration of their studies will be eligible for the scholarship. The scholarship is open to sponsored or self-funding students.
2. The availability of scholarships may be limited and subject to funding. Award of the MMU EMBA Corporate Scholarship is not guaranteed.
3. Candidates must be eligible to pay MMU's UK/EU or International tuition fees. Applications for the scholarship should be submitted on the MMU EMBA Corporate Scholarship form at the time of applying to the programme. Candidates will need to meet MMU's EMBA programme entry requirements. The scholarship will only be applied once an applicant accepts and meets the conditions of their offer to study on the EMBA.
4. Candidates will be required to provide evidence of employment by their Nominated Organisation in the [form](#) specified by MMU. There will also be an obligation to provide confirmation of continued employment on an annual basis.
5. Enrolled students must commence their studies and enrol on the same intake or over consecutive intakes in order to be eligible for these scholarships. Scholarships may not be deferred.
6. The scholarship will be awarded at the end of each academic year of study, however, please note that students must complete their EMBA programme successfully within four years of commencement; failure to do so will render the scholarship void for each student for any studies beyond that point.
7. This scholarship cannot be offered in conjunction with any other MMU scholarships/discounts/bursaries or tuition fee waiver.
8. A scholarship holder will be registered at MMU as an EMBA student and will be bound by the University's Regulations, procedures and codes in addition to these Terms and Conditions.
9. If a student is being sponsored by their Nominated Organisation (for tuition fee purposes) and the Nominated organisation does not make payment of their fees, the student will be invoiced directly in accordance with MMU's Payment Regulations.
10. The University reserves the right to withhold or withdraw the scholarship in the event that tuition fees are unpaid and full fees may be charged to the student thereafter.
11. Important – please note that the scholarship will only apply where a nominated organisation is employing two or more employees who are eligible for the scholarship. If the number drops below this limit, the student(s) will no longer be eligible for the scholarship and full tuition fees will apply. It will remain the responsibility of the student(s) and/or their Nominated Organisation to make adequate arrangements to ensure this minimum number applies during their period of study. MMU shall not be liable for any revocation of the scholarship in this regard. By signing these terms and conditions you are confirming that you fully understand and accept this key term.
12. MMU reserves the right to make reasonable changes to these Terms or revoke the scholarship at any time and for whatever reason, without liability (provided such revocation will not prejudice a currently enrolled scholarship holder).
